## PURPOSE

To provide clear and concise language regarding the consequences of a failure to meet the conditions of Conditional registration as set out in section 87 of the CSHBC Bylaws.

## SCOPE

Registered Audiologists (Conditional), Registered Hearing Instrument Practitioners (Conditional), and Registered Speech-Language Pathologists (Conditional).

## POLICY

### *Granting of Conditional registration*

Conditional registration is granted to applicants that meet the registration requirements set out in **section 82 (hearing instrument practitioners)** and **section 85 (audiologists and speech language pathologists)** of the CSHBC Bylaws, except for the entry-to-practice examination requirement and the hearing instrument practitioner supervised practicum requirement. Following receiving confirmation that their application has been approved, these individuals may use one of the following reserved titles:

- “Registered Audiologist (Conditional)” or “RAUD (Conditional)”
- “Registered Hearing Instrument Practitioner (Conditional)” or “RHIP (Conditional)”
- “Registered Speech-Language Pathologist (Conditional)” or “RSLP (Conditional)”

### *Conditions of registration -- timeframes & deadlines*

Conditional audiologist and speech-language pathologist registrants must register for their first attempt at the entry-to practice examination required for Full registration under the CSHBC Bylaws within six months of being granted Conditional registration.

Those registered as RHIP (Conditional) must complete their required supervised practicum hours within 12 consecutive months from the date of RHIP (Conditional) registration (see *RHIP Conditional Practicum Requirements* (POL-R-02)), for detailed practicum information and requirements).

Those registered as RHIP (Conditional):

- must register for their first attempt at the written entry-to-practice examination within 6 months of completing their supervised practicum hours; and

- are eligible to enroll in the practical exam once they have successfully completed the required supervised practicum hours and the ILE written examination.

Conditional registration lasts for two years from the date it is granted, unless a conditional registrant fails an entry-to practice examination three times within this period, in which case their registration is cancelled.

Conditional registrants must renew their registration by March 31<sup>st</sup> of any given year. For information about renewal deadlines and requirements, see *Registration & Certified Practice Renewal Requirements* (POL-R-11).

### Limits & conditions

Conditional registrants must work under GENERAL supervision<sup>1,2</sup>. They must not practise as a sole practitioner, supervise, or delegate any aspect of their practice, or supervise individuals who are fulfilling conditions or requirements for registration under the CSHBC Bylaws.

See the CSHBC [Supervision](#) standard of practice for further information regarding supervision.

Conditional registrants are ineligible to be nominated or elected as Board Members but may vote in Board elections and general meetings of the College.

### Full registration

Upon providing proof of a successful entry-to practice examination result, where the examination was attempted no more than three times and within two years of the date that Conditional registration was granted, CSHBC will register the Conditional registrant in question as a Full registrant.

Proof of passing the entry-to practice examination must be sent to CSHBC directly from the examination administrator.

### Cancelation of Conditional registration

Pursuant to CSHBC Bylaw section 87(5), CSHBC must cancel a Conditional registrant's registration if:

- They do not provide proof of passing the entry-to-practice examination(s) within two years of being granted conditional registration; or
- They fail an entry-to-practice examination three times.

Conditional registration is only granted once. If Conditional registration is cancelled or a Conditional registrant fails to renew their registration by March 31<sup>st</sup>, applicants are no longer eligible to re-apply for Conditional registration and may only apply for Full registration.

<sup>1</sup> "General supervision" means supervision where the supervisor is accessible to a supervisee, but does not attend in person. General supervision is synonymous with remote supervision. Access may be by telephone, email, or virtually.

<sup>2</sup> This applies to Conditional RHIPs once they have successfully completed their supervised practicum requirements. For information on RHIP (Conditional) supervision requirements during practicum, see *RHIP (Conditional) Practicum Requirements* (POL-R-02).

### ***Failure to comply with Conditional registration requirements & conditions***

If a registrant fails to comply with one or more of the following requirements, limits and conditions of Conditional registration, the matter may be referred to the CSHBC Registration Committee or Inquiry Committee:

- Attempting the entry-to-practice examination more than three times within two years of being granted Conditional registration.
- Practising as a sole practitioner, without the general supervision of a CSHBC registrant.
- Supervising or delegating any aspect of practice.
- Supervising other registrants who are fulfilling conditions or requirements for registration under the CSHBC Bylaws.
- Using their reserved title without qualifying that title with the word “Conditional”.
